### ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM *(Please read)*

- ❖ Water Heater rebate must be **submitted no later than 3 months after purchase date** and must be installed on cooperative's lines.
  - ❖ Rebate not to exceed cost of high efficiency equipment.
  - ❖ Installed equipment must be on cooperative's lines **and must be enrolled in the Cooperative's load control program.**
  - ❖ Rebates are in place through December 31, 2018 or until funds are depleted.
  - ❖ Rebates submitted after December 31, 2018 will not qualify if the rebate is no longer offered in 2019.
  - ❖ Additional eligibility criteria may apply. Contact cooperative for details. Program is subject to change or cancellation without notice.
  - ❖ All documentation listed below must be **submitted no later than 3 months after purchase date of water heater.**
- Members are encouraged to submit as soon as possible to ensure rebate.
