

ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM *(Please read)*

- ❖ New equipment rebate(s) must be **submitted no later than 3 months after purchase date** and must be installed on cooperative's lines.
- ❖ Rebates are in place through December 31, 2018. Funds are limited so members are encouraged to submit as soon as possible.
- ❖ Rebates submitted after December 31, 2018 will not qualify if the rebate is no longer offered in 2019.
- ❖ Rebates not allowed for a measure and a component of that measure. For example, if an air source heat pump has a variable speed blower motor, the air source heat pump qualifies for a rebate but not the variable speed blower motor.
- ❖ Rebate not to exceed 20% of the cost of equipment. Additional eligibility criteria may apply. Contact cooperative for details.
- ❖ All documentation listed below must be **submitted no later than 3 months after purchase date**.
 - ✓ **This Rebate Form. Requests missing required information will be returned.**
 - ✓ **A dated copy of your receipt or invoice for each item purchased. Note: Proposals are not accepted.**
 - ✓ **AHRI Certificate, for all Air Conditioners, Heat Pumps and ECM Blower Motors.**
