- ❖ Equipment must be purchased in 2017 and must be installed on cooperative's lines.
- ❖ Rebates are in place through December 31, 2017. Funds are limited so members are encouraged to submit as soon as possible.
- ❖ Rebate not to exceed 50% of the cost of equipment.
- ❖ Additional eligibility criteria may apply. Contact cooperative for details.
- ❖ Bulbs receiving promotional pricing from **Freeborn Mower Cooperative** at Ace Hardware, Home Depot and Walmart, do not qualify for these rebates.
- ❖ All documentation listed below is required and must be **submitted no later than 3 months after purchase date**.
 - ✓ This Rebate Form.
 - ✓ A copy of your receipt or invoice for each item purchased.
 - ✓ For CFL and LED bulbs & fixtures, include UPC Code and Lighting Facts from package.
 - ✓ For all fixtures, include packaging or documentation showing number of lumens or number of bulbs per fixture as required.
